

- b) To carry on the business of investors and speculators in all branches of business, to buy, sell, import, export, lease, manage and deal in land shares, securities, merchandise and to deal in any other property wherever situated.

2. Regulations 24, 40, 41, 43, 53, 74, 75, 76, 78, 80, 83, 90, 91, 100, 113, 114, 127 and 130 of part I of Table "A" shall not apply to the company.
1. The regulations contained in part I of Table "A" of the First Schedule of the Companies Act Chapter 24:03 shall apply to the company as if the same were incorporated herein save insofar as may be excluded, modified, added, varied or revised hereinafter, and in the event of there being a conflict between Part I of Table "A" and the articles appearing hereinafter, the latter shall prevail.

6. a) Upon any shareholder receiving an offer (which offer must be in writing) to purchase any shares held by that shareholder in the company and the shareholder is desirous of accepting, that shareholder (hereinafter called, the "transferor") shall transmit the aforesaid written offer together with a written notice (hereinafter called, "the transfer notice") to the Directors of the company who shall constitute the agents of the transfer of those shares.
5. The Directors may in their absolute discretion and without assigning any reason(s) therefore, decline to register any transfer of any share whether or not it is a fully paid share save as provided for in article 6 hereof.

TRANSFER OF SHARES

4. Shares in the initial or increases capital of the company, unissued or forfeited shares or shares for which notice has been given or deemed to have been given shall be under the control of the Directors: and subject only to any directions of the company given in General or other Meeting, the Directors shall first offer the aforesaid shares to the existing members of the company, as nearly as possible, in proportion to their shareholdings.

- (d) Any invitation to the public to subscribe of any shares or debentures of the company is prohibited.

- (c) PROVIDED THAT where two or more persons hold one or more shares in the company jointly, they shall, for the purpose of this article, be treated as a single member.

- (b) The number of members of the company (excluding persons who, having been formerly in the employment of the company were, while in such employment, members and have continued after the termination of that employment to be members of the company) is limited to fifty (50).

- (a) The right to transfer shares is restricted in the manner hereinafter prescribed.
