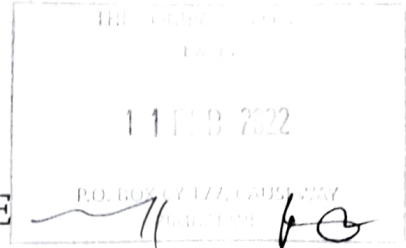

- (e) In case of a foreign company, if the director is a corporate body, its name and situation of its principal office must be shown
- (f) In the case of the secretary being a corporate body, the name and the situation of its registered office must be given
- (g) In the case of the principal officer being a corporate body or partnership, the corporate or partnership name must be shown, and if it is a partnership, all the names of the partners must be shown.
- (h) In the case of an individual, if he is a director of any other company registered in Zimbabwe, the name of every such company must be entered. This applies only in respect of new appointments.
- (i) State 'Resigned' 'Retired' 'Died' or as the case may be. In case of a new appointment since the last list was filed, it must be stated here in whose place or whether additional.
- (j) Give the date of the occurrence referred to in the previous column. Both columns 8 and 9 must be completed in the event of a change.
