

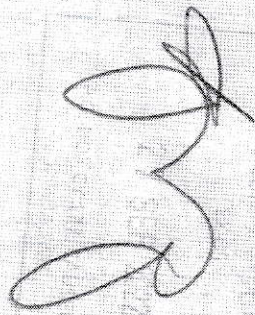

NOTES

- Complete list of the existing directors should always be given.
- This date should always be shown, whether or not it is in respect of an old or a new appointment.
- Particulars of Directors, Secretaries or Principal Directors.
- Nationality, Identity number or passport number must be shown in this column.
- In the case of a foreign company, if the director is corporate body, its name and the situation of principle office must be shown.
- In the case of the secretary being a foreign body the name and the situation of the registered office must be given.
- In the case of the principal officer being a corporate body or partnership, the corporate partnership name must be shown and if it is a partnership all the names of the partners must be given.
