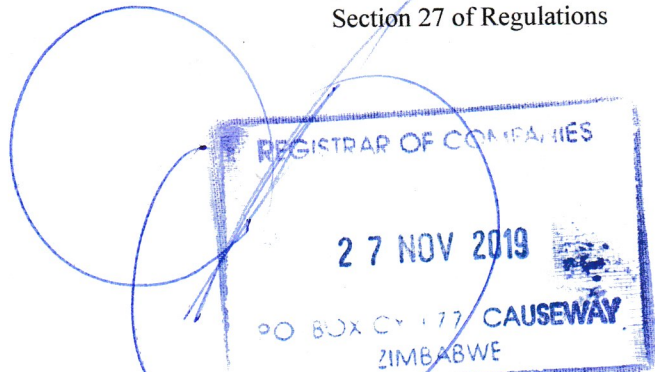

Notes:-
