

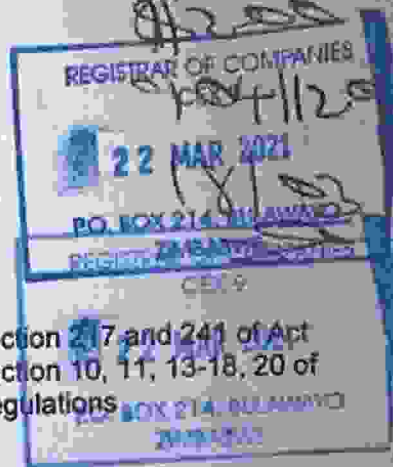

The list of the existing directors should always be given.

It should always be shown whether or not it is in respect of an old or new appointment.

For directors, secretaries or principal officers.

For directors, secretaries or principal officers, the entity number or passport number must be shown in this column.

If a foreign company, if the director is a corporate body, its name and the situation of its principal office must be shown.

If the Secretary being a corporate body, the name and the situation of its registered office must be given.

If the principal officer being a corporate body of partnership, the corporate/ partnership name must be shown, and, if it is a partnership, all the names of the partners must be shown. If an individual, if he is a director of any other company registered in this country, the name of every such company must be entered. This applies to "Retired", "Died" or as the case may be. In the case of a new appointment since the last list was filed, it must be stated here whether or whether additional.
