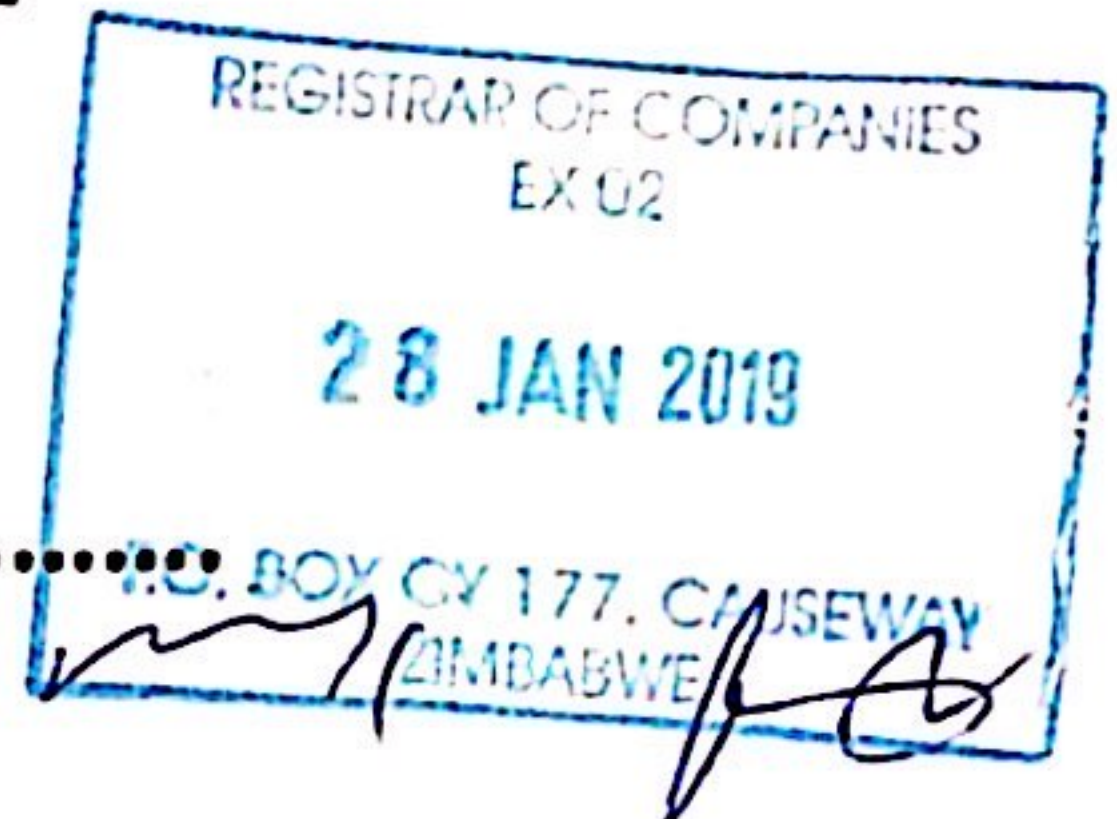

NOTES

- (a) A complete list of the existing directors should always be given
- (b) This date should always be shown, whether or not in respect of old or new appointment
- (c) In the case of a foreign company, if the director is a corporate body, its name and the situation of the principal office must be shown
- (d) In the case of the secretary being a corporate body, the name and the situation of its registered office must be given
