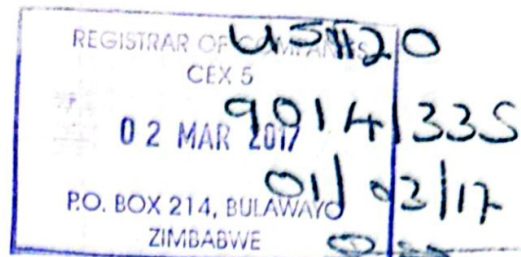

**NOTES**

- (i) This is regarded as the effective date of the entry in the register.
