

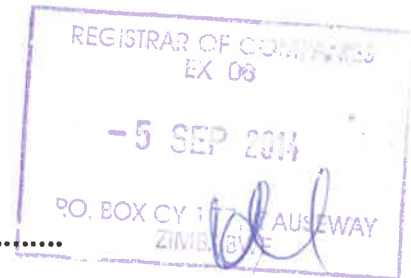

NOTES

- (a) A complete list of the existing directors should always be given.
