NOTE 3—

- (a) A complete set of the existing fixtures should always be kept.

(b) If the fixtures are to be sold separately, it is recommended that a copy of the original offer made to the buyer be retained by the seller. This will enable him to determine whether or not the fixtures are included in the sale.

(c) In the case of fixtures which are not part of the equipment used in the business, such as a telephone, it is preferable that all the fixtures be removed and placed in a separate account.

(d) In the case of an individual who is a collector of fixtures, the name of every fixture should be listed in the account.

(e) If fixtures are to be sold separately, it is recommended that they be sold at a price which is less than the amount of the money loaned.
