

- a) To carry on the trade or business of pharmaceuticals, manufacturing, and distribution of medical and laboratory equipment and accessories, personal protective equipment together with any other business usually carried on in connection therewith.
- b) To carry on the business or trade of medical services, surgeries, maternity homes, nursing homes, medical supplies, consumables, medical and laboratory equipment and accessories, medical care products, distribution of explosives for use in laboratories together with any other business usually carried on in connection therewith
- c) To carry on the business or trade in investments together with any other business usually carried on in connection therewith.

- x) To acquire by grant, purchase , license, or otherwise , any patents , patents rights , brevets, inventions , copyrights , trademarks , protections and concessions which may appear likely to be advantageous or useful to the company ,or which it may be desirable for the Company to possess and to use and turn to account and to manufacture under or grant licenses or privileges in respect of the same , and to expend money in experimenting upon and testing and in improving or seeking to improve any patents , inventions , or rights which the Company may acquire or propose to acquire.

The shares of the company may be increased or decreased from time to time in accordance with law and the Articles of Association of the company by increasing or decreasing the number of its shares or creating other classes of shares with the power to divide the shares in the original or any increased capital into several classes and to attach there to respectively any preferential, deferred, qualified or special rights, privileges or conditions.

## COMPANIES AND OTHER BUSINESS ENTITIES ACT (CHAPTER 24:31)

#### ARTICLES OF ASSOCIATION

OF RAMVIC CHEMICALS (PRIVATE) LIMITED

- 1. The regulations contained in table B in the 6<sup>th</sup> Schedule (Model Articles and bylaws) of Companies and Other Business Entities Act Chapter (24.31), shall apply.
- 2. The Company is a private company and accordingly -
  - (a) The right to transfer shares is restricted in the manner hereinafter prescribed;
  - (b) The number of members of the company, exclusive of persons who are in the employment of the company and of persons who have been formerly in the employment to the members of the company, is limited to fifty.

2/(C) Provided....



- (c) Provided that were two or more persons holding on one or two shares in the company jointly they shall for the purpose of this regulation be treated as single member.
- (d) Save as provided by the last paragraph of this Article no share shall be transferred to any person unless and until the rights of pre emption, hereinafter conferred shall be exhausted.
- (e) Any invitation to the public to subscribe for any shares or debentures of the company is prohibited.
- (f) Any shareholder desiring to transfer or dispose of any of that Shareholder's Shares called the "Vendor" shall give thirty days written notice (called "offer notice") to each of the remaining shareholders upon the terms and at a price specified in the offer notice.
- (g) If after the expiry of the notice the total number of shares for which offers have been received from each of the remaining shareholders is equal to or greater than the number of shares which the Vendor has offered to transfer, the Vendor shall transfer to or amongst the remaining shareholders who shall have made offers on a pro rata basis: provided that none of the remaining shareholders shall be obliged to take more than the maximum number of shares so notified to the Vendor.
- (h) If after the expiry of the offer notice number of shares for which offers have received from each of the remaining shareholders is less than the number which the Vendor has offered to transfer has offered, the Vendor shall for a period of sixty days only from the date of expiry of the offer be entitled to transfer to any person at the same price and upon the same terms as were one of these exceptions.
- (i) The provision hereof relating to transfer of shares shall not apply to a transfer of merely for the purpose of effectuating the appointment of new trustee, nor to a transfer by personal representative of a deceased member to heir an intestate or to a legatee or heir under the Will provided to the satisfaction of the Board that the transfer bona fide falls within one of these exceptions.
- 3. The directors may, in their absolute discretion and without assigning any reason therefore, decline to register any transfer of any share, whether or not it is fully paid share.
- 4. Subject to the Act, a resolution in writing signed by all the members for the time being entitled to receive notice of and to attend and vote at general meetings or, being corporations, by their duly authorized representative shall be as valid and effective as if the same had been passed at a general meeting of the company duly company convened and held.
- 5. The subscribers to the memorandum shall be the directors of the company and shall hold once until directors of the company are appointed by the company in general meeting.
