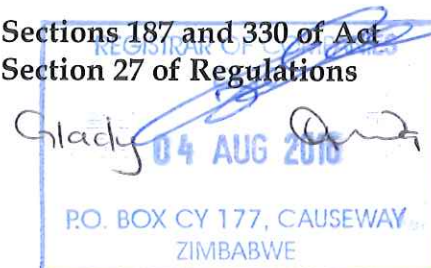

NOTES:
