3. A PBC can have minimum of one member and maximum of twenty members.
4. Only individuals are allowed to be members of PBC.
5. If the member of PBC wishes to include the objects of the PBC in the Incorporation statement, they may do so.
6. The total of percentage of the member's interest must add up to 100.
7. With regard to services, you may only include services rendered to ward the formation or registration of the PBC. you may not include services rendered to the PBC after it is registered.
8. The qualifications for an accounting officer are specified in the regulations.
