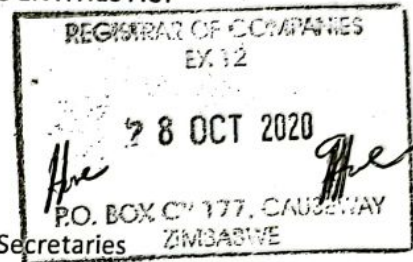

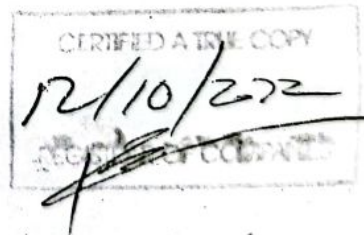

(a) A Complete list of existing directors should always be given.

(b) This date should always be shown, whether or not is in respect of an old or a new appointment.

(c) Particulars of Directors, Secretaries or Principal Officers

(d) National identity number or passport number must be shown in this column
