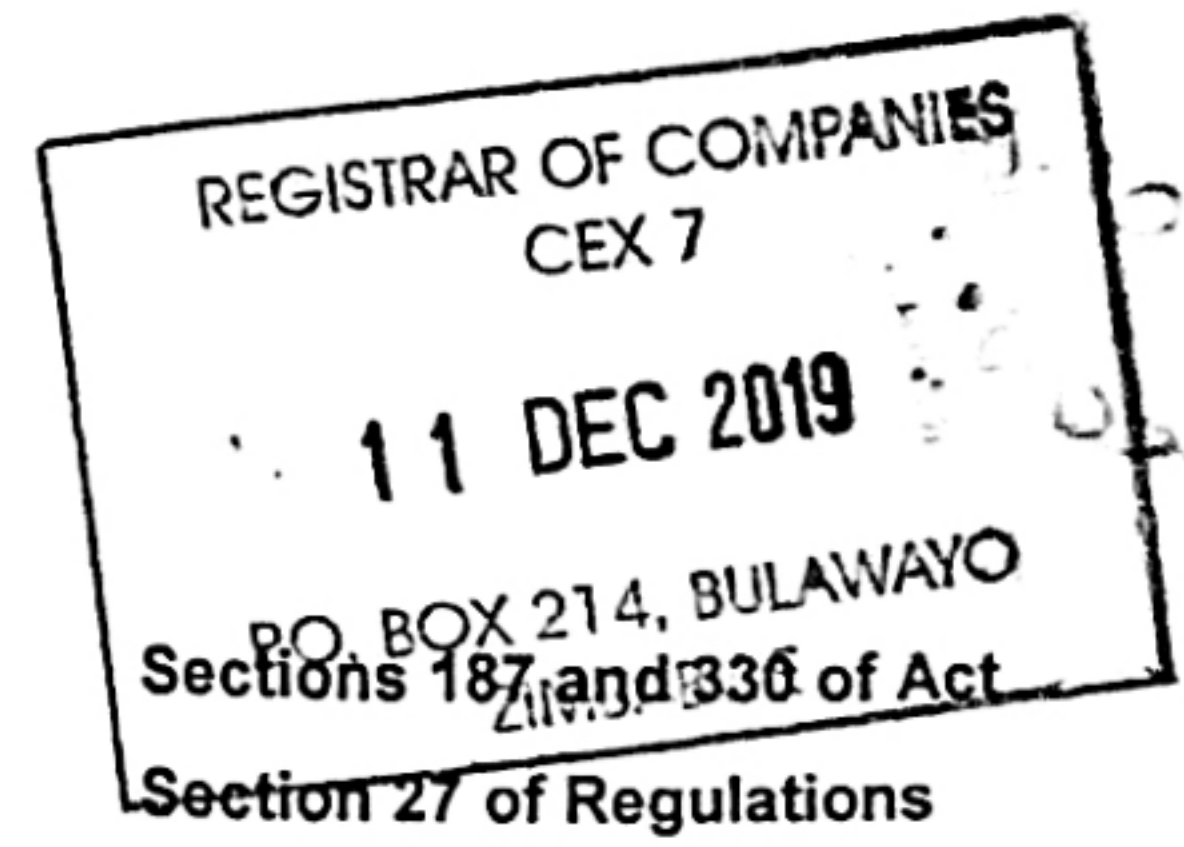



NOTES:-A complete list of the existing directors should always be given.

(h) This is regarded as the effective date of entry in the register.
