- 1 The name of the Company is E T D CONSULTING (PRIVATE) LIMITED
- 2 The objects for which the Company is established are:-
 - (a)
 - I. To provide the services of accounting, secretarial and general business advise.
 - II. To do business as trucking and haulage services providers and public transport operators.

- III. To engage in all or any of the businesses of general dealers, retailers, millers, wholesalers, merchants, manufacturers, hawkers, and the like, dealing in all commodities, goods, merchandise, supplies, beverages and requirements of every kind and description.
- (b) I. To acquire movable and immovable property, trademarks, patents, licenses, permits and the like by purchase, exchange, or in any other manner, and to take delivery and transfer thereof into the name of the company, in such manner and on such terms and for such amounts as the Directors shall determine.
- II. To dispose of any movable and immovable property of the company by sale, exchange or in any other manner, and to take delivery thereof and transfer out of the name of the company, in such manner and for such amounts as the Directors shall determine.
- III. To register mortgage and all other types of bonds over the movable and immovable property of the Company, as the Directors shall determine.
- IV. To hire, lease, and let property and premises of every description, for and on behalf of the company in such manner and on such terms and for such amounts as the Directors shall determine.
- V. To borrow or raise and secure the repayment of money in such manner and on such terms as the Company shall think fit and in particular by overdraft or loans from bankers or others or on mortgage, or by general or special bond, or by the issue of debentures charged upon the whole or any part of the undertaking, property and assets of the Company, both present and future, including its uncalled capital, or by the issue of preferential dividend.
- (c) To open banking accounts, to draw, make, accept, endorse, discount, execute, issue and negotiate cheques, bills of exchange, promissory notes, bills of lading, warranties, debentures and other negotiable or transferable instruments.
- (d) To lend money to any person or Company, and on such terms as may seem expedient, and in particular to any person or company having dealings with this Company, and to guarantee the performance of contract by any such person or company

- (e) To remunerate any person or persons either in cash or by allotment of shares, credited as fully or partly paid up, for services rendered in the formation of the company or in the development of its business.
- (f) To acquire, hold and sell shares, stocks, debentures, debenture stock, mortgage bonds and securities of all kinds.
- (g) To distribute the assets of the Company among its members in shares or in kind upon the company being wound up.
- (h) To act as consultants and advisors to the construction contractors, estate agents, real estates, farming, industrial and commercial sectors of the economy in the field of construction.

- (k) To transact and carry on all kinds of agency business and in particular in relation to the investment of money.

- (n) To do all such other things as are incidental or conducive to the attainment of the above objects.

ARTICLES OF ASSOCIATION
OF
E T D CONSULTING (PRIVATE) LIMITED

PRELIMINARY

- I. The regulations in part 1 and part 11 of Table A in the First Schedule to the Act shall not apply to the Company.

INTERPRETATION

- 2 In these regulations;-
The Act means the companies Companies Act, (Chapter 24:03) as amended from time to time;
Secretary means any person appointed to perform the duties of the secretary of the Company;
The office means the Registered office of the Company.

Unless the context otherwise requires, in these Regulations words of the singular number shall include the plural, words of the plural number include the singular and words or expressions herein contained shall bear the same meaning as in the

Act or any statutory modification thereof in force at the date at which these regulations become binding on the Company.

- 3 The Company is a Private Company and accordingly:-
- (a) the right to transfer shares is restricted in manner hereinafter prescribed;
 - (b) the number of members of the Company (exclusive of persons who are in the employment of the Company and persons who having been formally in the employment of the company were while in such employment and have continued after the determination of such employment to be members of the Company) shall be limited to fifty (50); provided that where two or more persons hold one share for the purposes of this Regulation be treated as a single number;
 - (c) any invitation to the public to subscribe for any shares or debentures of the Company is prohibited.

ARTICLES OF CAPITAL

- 4 The Company may from time to time, by special resolution, increase the share capital by such sum, to be divided into shares of such amount as the Resolution shall prescribe.
- 5 The Company may, by special resolution , reduce its share capital in any way as provided for in terms of section 92 (1) of the Act

SHARES


- 6 The shares shall be at the disposal of the directors who may, subject to the provisions of article 8 allot or otherwise dispose of them to such persons at such times and generally on such terms and conditions as they think proper. Every share certificate shall be signed by the Director and the company Secretary.

TRANSFER OF SHARES

- 7 A share may be transferred by a shareholder or other person entitled to transfer, to any shareholder selected by the Transferor, provided that, notwithstanding anything to the contrary contained in the articles, the Directors of the Company may, in their absolute and uncontrolled discretion, and without assigning any reason, refuse to register any proposed transfer of a share or shares in the company, and provided further, that before any existing shareholder shall be capable of transferring any share to any person, not already a shareholder of the Company, the remaining shareholders or any of them shall have the right of

- 23 If the Company shall be wound up, whether voluntarily or otherwise, the liquidator may, with the sanction of an Extraordinary Resolution, divide among the contributories in specie any part of the assets of the Company, may with like sanction, vest any part of the assets of the Company in Trustees upon Trust for the benefit of the contributories as the liquidator with like sanction shall think fit.


