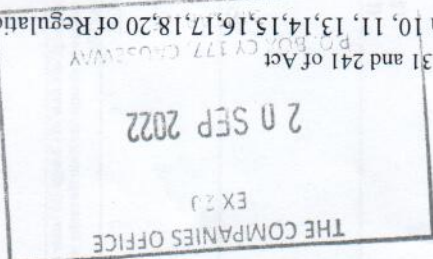

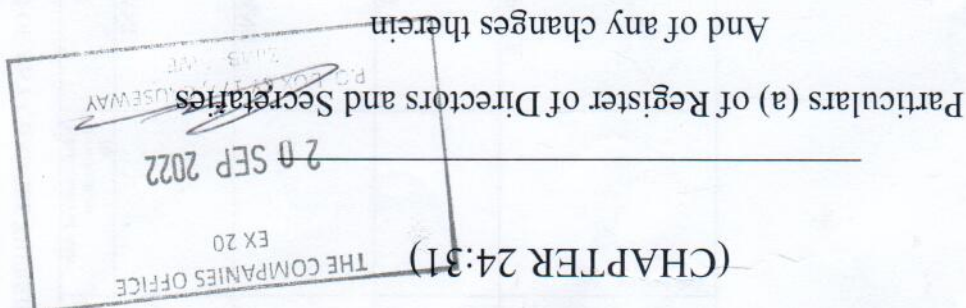

- Particulars of Directors, Secretaries or Principal Officers.
- National identity number or passport number must be shown in this column.
- In the case of a foreign company, if the director is a corporate body, its name and situation of principal officer must be shown.
- In the case of the secretary being a corporate body, the name and the situation of its registered office must be given.
- In case of the principal officer being a corporate body or partnership name must be shown and if it is a partnership all the names of the partners must be shown.
- In the case of an individual if he is a director of any other company registered in Zimbabwe, the names of every such company must be entered. This applies only in respect of new appointments.
