1. The name of the company is

2. The objects of which the company is established are:



- a) To carry on the business of activities related to transportation of goods and services.
- b) To carry on the business of buying, selling, reselling, importing, exporting, transporting, storing, developing, promoting, marketing or supplying, trading, dealing in any manner whatsoever in all type of goods on retail as well as on wholesale basis in Zimbabwe or elsewhere.
- c) To cultivate, grow, produce or deal in agriculture produce and to carry on the business of agriculturists, farmers, gardeners, dairy farmers, and to acquire, hold, buy or acquire freehold or leasehold agriculture land, farm, garden or any other, property and to act as growers of crops, seeds or animal feed and to deal in live-stock and deal in such business as may be required by farmers and dealers of agriculture produce.
- d) To carry on the business of manufacturing, buying, selling, producing, processing, importing, exporting, distributing, trading, supplying, running, managing and dealing in all kinds of food, food products, dairy products, bakery & confectionery products, whether as owners, co-owners, joint ventures, operators, franchisees, franchisers and/or any other business model.
- e) To carry on the business of activities related to e-commerce, e-shopping, ebusiness, multimedia services, online information services, online application integration including buying, selling, marketing, trading and otherwise dealing in various kinds of products on internet.
- f) To carry on the trade or business as property agents, property managers and developers, to buy and improve, renovate and maintain properties, to develop townships and subdivisions of the same, to manage business, land, buildings and other property whether belonging to the Company or not and to collect rents and income and to supply tenants and occupiers or other with services of all types and to carry on any other business which maybe incidental thereto.
- g) To carry on the business of developing, designing and maintenance of websites, web-based applications and internet or network related system or solutions including setting up of portals, internet based services and consultancy and other value added services.

None of the sub-clauses of the objects therein specified, or the powers conferred, shall be deemed subsidiary or auxiliary merely to the objects mentioned, but the company shall have full power to exercise all or any of the powers conferred by any part of this Memorandum in any part of the world, notwithstanding that the business, undertaking, property or acts proposed to be transacted, acquired, dealt with or performed do not fall within the objects of this Memorandum.

- 3. The liability of the members is limited.
- 4. The total number of shares for the company shall be 2 000 (Two Thousand) Ordinary Shares. The company shall have the power from time to time to increase or reduce its shares either before or after allotment into several classes, and to attach thereto any preferential, deferred, qualified or special rights, privileges, conditions or restrictions or to convert the whole or any part of the shares of one class into shares of another class.
