Section 7 – Challenges/Recommendations

Determining an accurate value for a specific Cannabis product amongst the huge, and poorly defined, diversity of products derived from Cannabis is challenging. In the initial stages, establishing value appears to be based heavily upon customer assessment, including independent chemical analysis, of an actual sample of the product. Current agricultural export regulations limit export of any quantity of agricultural produce to a maximum of two specified countries. This hampers marketing efforts as effectively only two international markets may be explored through provision of product samples at any time. Applying for multiple exports is costly, time consuming and counterproductive, as not all export permits will be followed by any actual commercial export. A more practical system that allows simultaneous export of sample quantities of Cannabis derived product to multiple markets (multiple counties) needs to be developed.
