

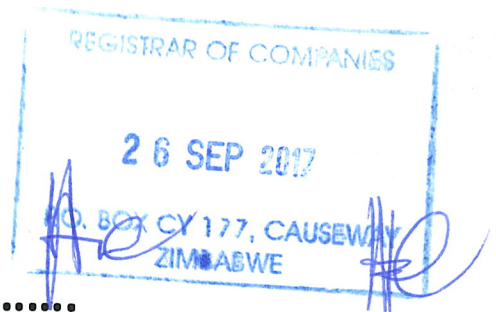

NOTES
