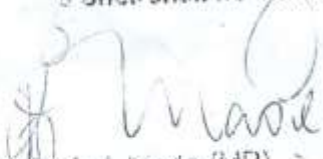

1. The Minister of Lands, Agriculture and Rural Resettlement has the pleasure to inform you that your application for land under the Model A2 Scheme has been successful.
2. You are offered Subdivision **26** of **HALESTAD** in **MWERUNGWE** district of Masvingo Province for agricultural purposes. The farm unit offered is approximately **33.30** hectares in extent.
3. This offer is made in terms of the provisions of the Land Reform Act (Chapter 20:01) and its provisions, and you are advised to acquaint yourself with Conditions that go with the offer are attached.
