

**FARMING PARTNERSHIP AGREEMENT**

**Between**

**MEZZI ESTATES (PVT) LTD  
("MEZZI")**

**represented herein by Nyasha Madzika, she being duly authorized**

**and**

**PROGROW ENTERPRISES ENTERPRISES (PVT) LTD  
Represented by Eric Coleman he being duly authorized  
("PROGROW")**

**WHEREAS**

- A MEZZI is the owner of a farm situate in the District of Headlands called Mezzi Estates ("the Farm")
- B PROGROW has the skills and much of the equipment necessary to carry out farming operations: and
- C In the circumstances Mezzi and Progrow have reached agreement as to the basis upon which they will enter into a partnership for the purpose of conducting farming operations on the Farm.

**NOW THEREFORE IT IS AGREED AS FOLLOWS:**

**1. Business of the Partnership**

During the currency of this agreement the parties have agreed to conduct a business in terms of which farming operations shall be conducted on the Farm for their joint benefit, in particular involving the seasonal growing of not less than 40 hectares of Virginia Tobacco, and the marketing of such tobacco, it being particularly recorded that any crops grown on the Farm in addition to a tobacco crop shall be grown at the risk of, and for the profit of Progrow.

**2. Period**

Notwithstanding the date of signature hereof this agreement commenced on 1 September 2016 and shall continue for a period of Ten (10) years, unless sooner terminated on not less than 18 months written notice given by either party to the other and terminating at the end of a tobacco season (i.e. on 31 August); or otherwise as provided herein.
