(Issued in terms of the Animal Health Act 1996)

Subject to the following conditions:

The goods are accompanied by a certificate signed by a Government Veterinarian on the effect that  
Goods originate from areas free from foot and mouth disease and African swine fever during the  
previous six months and from an area free from East Coast Fever during the past three years

OR

The goods have been out of all possible contact with these diseases for a period of 60 days prior to  
export (an Affidavit to this effect is to be supplied by the exporter)

**Cotton Seed, Soya Cake, Sunflower and Groundnut Cake**

1. In the case of cotton seed, soya cake and ground nut cake it has been subjected to  
heat treatment to a minimum temperature of 95°C degrees Celsius for a  
period of 10 minutes
2. The groundnuts cake, soya cake and cotton seed cake have been packed in clean bags  
which have not been in contact with livestock

**CONDITIONS TO BE FULFILLED BY ZIMBABWE STOCK FEED MANUFACTURER  
UPON ARRIVAL AT THE STOCK FEED MANUFACTURER'S PREMISES IN  
ZIMBABWE THE GROUND-NUT CAKE, SOYA CAKE OR COTTON SEED CAKE  
SHALL BE EMPTIED FROM THE BAGS. THE BAGS MUST NOT BE RE-USED FOR**



ANIMAL FEEDING STUFFS OR SOLD UNTIL EFFECTIVELY STERILIZED BY THOROUGHLY SOAKING IN A 4% SOLUTION OF SODIUM CARBONATE (WASHING SODA) ALTERNATIVELY THE BAGS ARE TO BE SEGREGATED FOR A PERIOD OF NOT LESS THAN 6 MONTHS BEFORE BEING PUT TO ANY FURTHER USE

N.B All bags or other containers to be free of cotton seeds and all vehicles used in transport to be swept clean of cotton refuse and this to be destroyed under supervision of a Plant Inspector where practicable. The Plant Inspector at Harare, Bulawayo, Mutare is to be confirmed of the expected time of arrival of the consignment there this is appropriate.


